1. Review meeting minutes on 07 November 2014

Meeting minutes was not approved subject to

- No CSO vote members present in today meeting
- Industries (ConocoPhillips) request for mini revision and circulate to MSG via mail it was accepted
- Industries (Eni) has no comment due to not presented in the previously meeting however only request a clarification MS have contact and request Eni to provide external auditor certification for the reporting templates, as Eni understand that MSG appointed MS at the same time certify the data report submit by reporting entities.

As explain by TL-EITI Secretariat refer to the EITI requirement 5.2 c agree on the assurances to be provided by reporting entities to the IA which is means that all information that submitted by reporting entities should consistent with their audited financial statements and have audited in accordance with the international standard.

2. Update TL-EITI 2012-2013 report

Secretariat informed that all government entity has submitted the reporting templates expected Industries (Minza, Ausaid etc). MS will send draft reporting by next week (15 Dec), MSG suggested while waiting for other companies to submit the reporting templates to reconcile, Industries (Eni) propose to send the draft reporting narrative in order to review the content, sentence and structure which should align with the EITI standard.

Industries have informed that the Confidential Agreement and reporting templates has send to MS

MSG will continue to discuss the TL-EITI reporting in the next meeting.

Action: Secretariat will contact MS to send draft reporting narrative first while waiting for other companies to submit the reporting template.

3. EITI International Secretariat visit Timor-Leste

Secretariat informed that Dyveka Rogan, Regional Director EITI International Secretariat not able to visit timor-leste on 1st and 2nd she has postponed to 3 week of December.

MSG informed only available either on 17or 18 December and 20 December onward will take annual leave till 5th January 2015. Or MSG suggested rescheduling to the next January 2015.

Action: secretariat will re-confirm with Dyveka which days are suitable then will call for next meeting.

4. Other Business

- Draft EITI law

MSG suggested inviting Miranda to explain and make presentation for this draft EITI law which of this law are connected to each other (decree law, regulations Diploma Ministerial), once all MSG have better understand then should carry out public consultation to obtain feedback from other stakeholders before present to parliament for debate.

Industry (Eni) informed they have internal process in review this draft EITI law in order to understand better the content.

Industry (ConocoPhillips) ask for Portuguese version

Government expresses the need to avoid any duplication law (Petroleum Fund Law, draft Minerals Law, so forth).

Secretariat TL-EITI informed that Miranda is available whenever we request, but we expect all MSG should present when the presentation is taking place because Miranda is using time count for charge.
