#### **TL-EITI WORK PLAN 2022**

## 1<sup>ST</sup> OBJECTIVE: To implement the recommendation from the last Validation and to prepare for the 2022 Validation in enhancing EITI principles in Timor-Leste

Rationale: Based on the 2016 Standard's second Validation report on February 2018, the EITI Board agreed that Timor-Leste has satisfactorily implemented the requirements adopted by the country. The last published TL-EITI report (FY2018) captured the objectives of requirements from 2019 Standard. The new requirements implemented by MSWG, such as, Beneficial Ownership (2.5), disaggregation information by gender (6.3d), and environmental reporting (6.4) were disclosed in the 2018 TL-EITI report. The usual disclosure of disaggregated information by revenues and by project level (4.7), data quality and assurance (4.9) and social expenditures (6.1) were also reported. The Independent Administrator (IA) is expected to assist MSWG & the National Secretariat with the Validation (transparency template) issued based on new module.

#### 2<sup>ND</sup> OBJECTIVE: To ensure the publication of EITI Report in timely manner and in accordance with EITI Standard 2019

**Rationale:** Tender process for IA commenced in 2021, however, selection of the IA along with other MSG activities were interrupted in the first months by the intense natural disaster and the Covid19 pandemic situation in the country. Most of these activities were restricted to the Government States of Emergency throughout 2021. In November 2021, the same IA was re-hired to assist with the preparation of the referred reports and Validation of MSWG impl ementation of 2019 Standard.

Improvement of TL-EITI reports means considering the disclosure of contextual information of the extractive industry activities (e.g. oil and gas and mining) in the country, attempting to reduce discrepancies within reconciliation. Following the completion of the Beneficial Ownership (BO) feasibility study, the MSWG decided to include BO information within the reporting data templates for the reporting entities. Furthermore, MSWG acknowledged the recommendations from International Secretariat (IS) on mainstreaming/systematic disclosure approach through its feasibility report in 2017. However, the process is delayed due to the State of Emergency declared throughout 2021. We could experience further delays in 2022.

In 2021, the 2nd objective could not be entirely implemented by the MSWG members and TL-EITI Secretariat due to limited facilities as results from the natural catastrophe and Covid19 issue. Hence, MSWG decided to request for extensions of Validation and TL-EITI report publication. A state budget was approved for this year's expenditure and the funding allocation for TL-EITI could cover the preparation of FY2019 TL-EITI report. Also, this section still includes the Annual Progress Report and the review of impacts of EITI implementation for activities that were carried out between 2019 and 2020. With the flexibility on the deadline as per 2019 Standard, the document will be published prior to EITI Validation on 1 July.

# 3<sup>RD</sup> OBJECTIVE: To encourage discussions on transparency in public expenditures, including investment decisions focus on economic diversification

**Rationale:** Enabling communication tools to the communities for accessing information about public expenditures and extractive activities in transparent manner. Through EITI, we expect local community can use EITI data to emphasize public debate and create discussions on extractive industry governance and on government activities in accordance to the relevant Laws in Timor-Leste. This objective particularly emphasized CSO active participation in EITI,

thus sought the importance of CSO contribution on EITI report and public debate. Previous work plan emphasized public debate with a targeted audience e.g. academic institutions or government members, however it could not possible held due to the Emergency State on Covid19 situation which lead to some academic institutions postponed their activities at schools/universities. This objective as disclosed in previous Work Plan still foresees the need to sharing information with specific audiences who may benefit the use of EITI information. The implementation of the activities described in the table below also relies on the approved state budget.

**Rationale:** MSWG acknowledge the importance of strengthening the EITI implementation within the country's legal framework. The ongoing debate on maritime boundary and the nation's extractive sector, changes within the relevant extractive laws and policies and legal reforms, updates on Mining Code Law and new PSCs have been monitored by the MSWG. MSWG also acknowledge the inclusion of contract transparency requirement that must be adhered in 2021. MSWG awares that some activities from this objective were not fully implemented in previous year and would attempt to discuss implementation of contract transparency in 2022.
