1. Main Achievement of Timor Leste due to preparation of the 15th TL-EITI Report

Some achievements are;

- Timor-Leste achieve milestone significant progress on the preparation under 2023 EITI Standard.
- Distributes and includes some improvements regarding the recommendations within the validation report.
- The report should be addressed the occupied level of gender.
- The current report also highlighted the impact of the Extractive Industries declaimed and Environment in Timor-Leste.
- Disclosed the process of environmental licensing and environmental impact assessment.
- The report also highlighted that in Timor-Leste there is ongoing project for carbon capture and Storage initiatives.
- The report also introduces the Gas Emission, Timor-Leste also the first EITI Country offers the level this information, regarding the Revenue reconciliation result and the result occurrence reach almost 99% Revenue reconcile.

2. Recommendations arising from 2022 Report and last Validation of Timor Leste

- The Anti-Corruption Pollution is the requirement, EY did some improvements. Anticorruption for SOE should be formalize and publicly available and it is available to take into stakeholder consideration.
- Availability Revenue for cash and cost project in new requirement that disclosed some important information to highlighted in the new requirement.
- Beneficial Ownership (BO) disclosure is a transparency area which reach the impact of last validation.
- Stakeholder consideration should be continuing the implementation of BO as having the register, publish on the TL-EITI government website which have on TL-EITI Report.
- Stake holder also take in consideration the pillars to be addressing some recommendations from last validation that the public debate should a part of Work Plan in EITI Implementation in Timor-Leste.

- The progress of Stake holder engagement is reviewed the outcome and impact in EITI Implementation in country.
- TL-EITI 2022 Final Report Approval for MSWG (Presented by TL-EITI National Coordinator, Emilia dos santos)
