Zeferino Soares (Timor Gap)

- Suggested to National Secretariat
  - To hire the local content should be professional can hire it from Secretariat or can be others.

Estevanus Coli (CSO)

- Suggested to National Secretariat:
  - In the contract it is not possible to mention the month but to mention the period because the work will be done in 2023, continue the consultation of the report, the translation of the report into Portuguese and Tetum, and will facilitate the Capacity Building for MSWG and we will also have a summary data.

Antonio dos Santos (Woodside)

- Suggested to National Secretariat:
  - The contract should set a time line for meeting with MSWG to deliver the work without having to meet directly but can be through online.
  - The contract must also be attached to the Minister's dispatch and minutes of meetings.
  - If possible, the legal team prepares the contract with performance review results for EY.
  - Meeting in person should be placed in the contract
- MSWG suggested to National Secretariat
  - Extend the contract from 01 / 07 / 2025 -30 / 07 / 2026.
  - The new bidding will open in next February 2026.

Isabela da Silva (ANP)

- Suggested to Secretariat TL-EITI
  - Maintain a contract with EY to produce the 2023 report and then open the new bidding.
  - To include local content in the next contract of TL- EITI report.
