#### **1. Approval of the agenda**

The meeting agenda was approved by MSWG members.

#### **2. Introduction**

The meeting opened by National Coordinator to the participants of the meeting that were represented by MSWG members from Government (ANP, ANM, MoF/AT, MoF/PF), SOE (TIMOR GAP, E.P), CSO and Independent Administrator (IA).

The agenda focused on the key achievements and recommendations from the 2023 EITI Report for Timor-Leste, along with the formal approval process. National Coordinator outlined the preparation timeline, which began in July and involved data reconciliation and review by the Multi-Stakeholder Group (MSG). Marcio Nunes and Mariia Khmura presented the report's significant achievements, including enhanced transparency in production data and beneficial ownership disclosure.

#### **3. Comment and Recommendations from MSWG**

##### **Estevanus Coli (CSO)**

We acknowledge the progress achieved since the previous year, but express concern about the ongoing challenges to meeting the EITI requirements, particularly regarding infrastructure and data accessibility. He also highlighted the continued need for greater civil society involvement in gender and environmental issues related to the extractive industry.

##### **Agostinho G. Ramos (ATTL)**

The independent administrator (Ernst & Young) must replace the cover images of the report with images of Bayu Undan or other images related to drilling in Timor-Leste.

#### **4. Result of the Meeting**

Based on some participants who did not participate at the meeting, the national coordinator of TL-EITI decided to extend the approval of the EITI report for fiscal year 2023, from December 19<sup>th</sup>-23rd December, 2025, via email.
